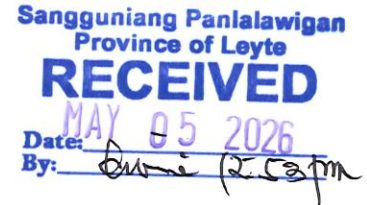

**WHEREAS,** the Municipal Ordinance No. 78, Series of 2017 created the San Isidro Economic Enterprise Development and Management Office and provided for its organizational structure;

**WHEREAS,** Section 4 thereof indicated the position title and corresponding salary grade but did not specify the corresponding plantilla item number;

**WHEREAS,** the Civil Service Commission requires that each position in the plantilla of personnel must have a corresponding item number for proper identification, appointment, and personnel actions;

**WHEREAS,** there is a need to amend Section 4 of the said Ordinance to include the specific plantilla item number to ensure compliance with CSC rules and regulations;

**NOW, THEREFORE, BE IT ENACTED** by the Sangguniang Bayan of San Isidro, Leyte, in session duly assembled that:

**SECTION 1. Amendment.** - Section 4 of Municipal Ordinance No. 78, Series of 2017 is hereby amended to include **specific Plantilla Item No. 160** corresponding to the position indicated therein, without altering the approved position title and salary grade.

**SECTION 2. Purpose.**- The inclusion of the plantilla item number is intended to ensure proper implementation of personnel action in accordance with Civil Service Commission standards and existing laws.

**SECTION 3. Appropriations.** - No additional appropriation shall be required as this amendment merely provides for the identification of an existing position.

**SECTION 8. SEPARABILITY CLAUSE.**

If any provision of this Ordinance is declared unconstitutional or invalid, the other provisions not affected thereby shall remain in full force and effect.

**SECTION 9. REPEALING CLAUSE.**

All ordinances, resolutions, executive orders, and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

**SECTION 10. EFFECTIVITY.**

This Ordinance shall take effect upon approval and compliance with publication and or posting requirements as provided by the Local Government Code of 1991.


