EXCERPT FROM THE MINUTES OF THE 47TH REGULAR SESSION OF THE 12TH SANGGUNIANG BAYAN HELD AT THE SESSION HALL, BARANGAY TABGAS, ALBUERA, LEYTE ON JUNE 8, 2026, AT 10:00 AM

RESOLUTION NO. 2026 – 135

A RESOLUTION RESPECTFULLY REQUESTING THE SANGGUNIANG PANLALAWIGAN OF LEYTE TO EXPEDITE THE HEARING AND RESOLUTION OF BOUNDARY DISPUTE BETWEEN THE MUNICIPALITY OF ALBUERA, THE CITY OF BAYBAY, AND THE MUNICIPALITY OF BURAUEN

WHEREAS, Section 10 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that disputes involving component cities and municipalities shall be referred to the Sangguniang Panlalawigan for settlement;

WHEREAS, a long-standing boundary dispute exists between the Local Government Units of Albuera, Baybay, and Burauen involving the delineation of their respective territorial boundaries;

WHEREAS, the unclear and unsettled boundaries have caused confusion among residents, hindered the effective delivery of basic services, affected revenue generation and resource allocation, and created administrative difficulties for the concerned LGUs;

WHEREAS, the prolonged delay in the resolution of this boundary dispute has resulted in unnecessary tensions and has prevented the affected LGUs from fully exercising their governmental powers and functions within their respective jurisdictions;

WHEREAS, the Sangguniang Panlalawigan of Leyte has the authority and mandate to conduct hearings and render a just and equitable decision on this matter;

WHEREFORE, on motion of Hon. Alberto C. Sumaljag unanimously seconded by all of the members present, be it

RESOLVED, to respectfully request the Sangguniang Panlalawigan of Leyte to expedite the hearing and resolution of boundary dispute between the Municipality of Albuera, the City of Baybay, and the Municipality of Burauen;

RESOLVED FINALLY, that copies of this Resolution be furnished to the Honorable Governor of Leyte, the Honorable Members of the Sangguniang Panlalawigan of Leyte, the Department Environment and Natural Resources (DENR), and the concerned LGUs of Baybay City, Leyte and Burauen, Leyte for their information and appropriate action..


