**MUNICIPAL ORDINANCE NO. 07, SERIES OF 2026**

**AN ORDINANCE IMPLEMENTING A "NO SEGREGATION, NO COLLECTION" POLICY IN THE MUNICIPALITY OF DAGAMI, PROVIDING GUIDELINES FOR PROPER WASTE SEGREGATION, AND IMPOSING PENALTIES FOR VIOLATIONS.**

**BE IT ORDAINED** by the Sangguniang Bayan of Dagami, Leyte, in session duly assembled:

**SECTION 1. Title.**

This Ordinance shall be known as the "No Segregation, No Collection Ordinance of the Municipality of Dagami."

**SECTION 2. Declaration of Policy.**

It is hereby declared the policy of the Municipality of Dagami to promote environmental protection, proper solid waste management, and public health in accordance with Republic Act No. 9003 (Ecological Solid Waste Management Act of 2000). The Municipality shall strictly enforce waste segregation at source to ensure efficient garbage collection and disposal.

**SECTION 3. Coverage.**

This Ordinance shall apply to all households, commercial establishments, institutions, and other entities within the Municipality of Dagami, including all barangays and the Poblacion.

**SECTION 4. Mandatory Segregation of Waste.**

All waste generators are required to segregate their waste at source into the following categories:

1. Biodegradable waste
2. Non-biodegradable waste
3. Recyclable waste
4. Special waste (as applicable)

Properly labeled containers shall be used for each category.

**SECTION 5. No Segregation, No Collection Policy.**

Garbage collectors are strictly prohibited from collecting unsegregated waste. Any household or establishment that fails to properly segregate its waste shall not be entitled to garbage collection services until compliance is made.

**SECTION 6. Information Dissemination.**

The Municipal Government, through the Municipal Environment and Natural Resources Office (MENRO) and in coordination with the barangays, shall conduct information and education campaigns regarding proper waste segregation. Notices of this policy shall be posted in all barangay halls and conspicuous places within the Municipality of Dagami.

**SECTION 7. Penalties.**

Any person or establishment found violating this Ordinance shall be subject to the following penalties:

- First Offense: Warning and mandatory orientation on proper waste segregation
- Second Offense: Fine of One Thousand Pesos (₱1,000.00)
- Third and Subsequent Offenses: Fine of One Thousand Five Hundred Pesos (₱1,500.00) or community service, at the discretion of the Municipal Government

**SECTION 8. Responsibility of Barangays.**

Barangay officials shall assist in the strict implementation of this Ordinance and monitor compliance within their respective jurisdictions.

**SECTION 9. Separability Clause.**

If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

**SECTION 10. Repealing Clause.**

All ordinances, rules, and regulations inconsistent with this Ordinance are hereby repealed or modified accordingly.

**SECTION 11. Effectivity.**

This Ordinance shall take effect fifteen (15) days after its approval and posting in at least three (3) conspicuous places in the Municipality of Dagami.
