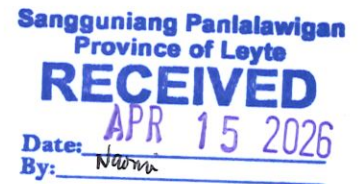



**ORDINANCE NO. 2026-001**

**AN ORDINANCE IMPOSING CHARGES, FEES AND PENALTIES TO BE COLLECTED FROM THE WATERWORKS SYSTEM IN THE MUNICIPALITY OF CALUBIAN, LEYTE**

**INTRODUCED BY: COMMITTEE ON FINANCE, BUDGET AND APPROPRIATIONS**

**WHEREAS**, a Public Hearing was conducted on January 5, 2026, attended by several Punong Barangays and/or secretaries, to whom a consultation regarding the proposed ordinance was conducted. The opinions of the attendees were taken into account on this Ordinance, as well as the input of the the representatives from the CAWASA;

**NOW, THEREFORE**

On motion of Hon. Jullian Marc A. Batiancela, and seconded by Hon. Eugenio A. Ching, Jr., and the majority of the SB Members present;

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF CALUBIAN, LEYTE**, in a session assembled, **THAT:**

**SECTION 1. IMPOSITION OF CHARGES.** The following fees and charges provided herein shall be collected for the water services rendered by the Waterworks System in the Municipality of Calubian, to wit:

**SECTION 2. TIME OF PAYMENT.** The monthly fee of service shall be due and payable to the Office of the Municipal Treasurer on or before the 10<sup>th</sup> day of the next following month.

For all other fees to be collected in Section 1 of this Ordinance, the same shall be paid upon the filing of the application or service to the Office of the Municipal Treasurer.

**SECTION 3. ADMINISTRATIVE PROVISIONS.**

- (a) A written application/ contract filed with the Office of the Calubian Water Services Administration (CAWASA) shall be required for the afore-mentioned services under Section 1 of this Ordinance.
- (b) The following shall be the documentary requirements for the application of waterworks services:
  - a. First Account:
    - i. Duly accomplished application form;
    - ii. Barangay clearance;
    - iii. Community Tax Certificate; and
    - iv. Sketch Plan/ Locational Map
  - b. Second Account:
    - i. Certification from the Municipal Treasurer of No unpaid balance of water service;
    - ii. Duly accomplished application form;
    - iii. Barangay clearance;
    - iv. Community Tax Certificate;
    - v. Sketch Plan/ Locational Map
- (c) For billing purposes, a water meter shall be read one (1) month after its connection and every month thereafter. The meter shall be sealed and the seal shall be broken only when the meter is to be inspected, tested, or adjusted by the system. It shall be tested at any reasonable time by the duly authorized representative/ inspector of the System or upon the request of the customer and to be witnessed by him if he so desires.
- (d) Service connection shall not use pipes bigger than one-half ince (1/2") in diameter.
- (e) Every multi-door apartment or residence shall have separate water service connection and separate water meter for every occupant or lessee therein.
- (f) If the testing of the water meter is upon request of the customer and the test disclosed that the water meter is defective, corresponding adjustments shall be made without any fee charged to the customer or account owner. However, if no defect is found in the water meter, the customer shall pay the system a Inspection Fee of ONE HUNDRED PESOS (PHP 100.00).
- (g) After the lapse of the due date of the 10<sup>th</sup> day of the next following month, a penalty fee of 10% of the amount due shall be charged to the consumer or account with a maximum of 2 months unpaid bill after three (3) calendar days upon receipt of the Notice of Disconnection if unsettled. The reconnection fee of FIVE HUNDRED PESOS (PHP 500.00) shall automatically be connected if after three (3) calendar days upon receipt of the notice of disconnection remains unpaid.

- (h) Customers whose water service connections has been disconnected due to delinquency or upon request of the consumer may re-apply for water service connection upon payment of the reconnection fee, unpaid water bills, and other charges as the case may be.
- (i) Landowners to which the water facilities of the waterworks system are located will be provided 20 cubic meters of potable water every month for free including installation. However, in excess of 20 cubic meters, they will already pay the corresponding monthly water service rates.
- (j) The Municipal Government of Calubian, Leyte reserves the right to disconnect the water connection to its consumers for any of the following reasons:
  - a. Non-payment of water bills;
  - b. Repair of waterworks fixtures and facilities;
  - c. Insufficient supply of water;
  - d. Culpable violation of the provisions of this Ordinance
  - e. Force majeure, and other fortuitous events, including acts of nature, typhoons, earthquakes and other similar events.

**SECTION 4. PENALTIES FOR WATER PILFERAGE.** After investigation, if the consumer or account is found guilty:

- i. First Offense: Php 500.00
- ii. Second Offense: Php 1,000 plus one-month suspension of water service
- iii. Third and Subsequent Offense: Php 2,500.00 or one month of imprisonment, or both, at the discretion of the court.

**SECTION 5. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

**SECTION 6. REPEALING CLAUSE.** All ordinances, rules, and regulations, other issuances or parts thereof which are inconsistent with this Ordinance is hereby repealed.

**SECTION 7. EFFECTIVITY.** This Ordinance shall take effect after fifteen (15) days from posting and publication, immediately upon approval of the Municipal Mayor and the Honorable Sangguniang Panlalawigan of Leyte.


