624 Government Code, unfortunately the Penal Provision Under Section 5 imposes fines which  
625 exceed the maximum penalty authorized for municipal ordinances under the same Section  
626 447(a)(1)(iii) of the Same Local Government Code. Further, I also have an additional concern,  
627 the wording not less than in the Penal Clauses are problematic because it does not establish  
628 an upper limit. For example, the ordinance says not less than 5,000. Well, it could mean  
629 10,000, 20,000 or higher. This effectively grants an unlimited penalty range, which is beyond

630 the authority delegated by the Local Government Code. Instead, the ordinance should provide  
631 not exceeding 2,500 or a fine of 2,500 if the intent is to impose the maximum allowable penalty.  
632 Accordingly, I move that this ordinance be referred back to the Sanguniang of the Dagami for  
633 amendment of its Penal Provisions to conform with the limitations prescribed under the Local

747 requisites to the issuance of mining, quarry and sand and gravel permits already governed by  
748 National Law. Since the authority to issue such permits is vested by RA 7942 in the appropriate  
749 National and Provincial regulatory agencies, there is a need to determine whether the  
750 requirements imposed by this ordinance merely supplement National Law or impermissibly ad  
751 conditions not contemplated by the Philippine Mining Act. Considering the need to harmonize  
752 the ordinance with RA 7942 while preserving the municipality's legitimate environmental and


