¹ (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:
(1) Approve ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection shall:
(ii) Maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition and impose penalties for the violation of said ordinances;

ORDINANCE NO. 01, S. 2026

AN ORDINANCE REGULATING THE ISSUANCE OF PERMITS ON HOLDING DISCOS AND BENEFIT DANCES IN THE MUNICIPALITY OF BARUGO, LEYTE

Sponsored By: Hon. Felix A. Diloy

Be it ordained by the Sangguniang Bayan of Barugo Leyte on its regular session assembled,
That:

Section 1: Title. This ordinance shall be known as the “Disco and Benefit Dance Ordinance of Barugo, Leyte

PURPOSE: Its purpose is to establish guidelines and regulations for the issuance of permits for discos and benefit dances to ensure the safety, health, and welfare of the public, and to regulate such events to minimize any negative impact on the community.

Section 2: Definition of Terms, For the purpose of this ordinance the following terms shall be defined as follows:

- 2.1 DISCO: A public event involving dancing to live/recorded music, typically in a club or hall setting.
- 2.2 Benefit Dance: A public event organized for a charitable purpose, where dancing is the primary activity, and proceeds are directed toward a specific cause or non-profit organization.
- 2.3 Permit: A Written authorization issued by the Municipality of Barugo, Leyte for the holding of a disco or benefit dance event.
- 2.4 Event Organizer: The individual or organization applying for the permit to hold the event.
- 2.5 Premises: The location or venue where the event will be held

Section 3: Permit Requirement

No person, group, or organization shall hold or conduct a disco or benefit dance within the jurisdiction of the Municipality of Barugo, Leyte without first obtaining a permit from the Local Chief Executive. The event must comply with all applicable local laws, including but not limited to Zoning Laws, Fire and Safety Code, Health Regulations, and Noise Ordinances.

Section 4: Application Process

- 4.1 Eligibility: Only individuals or organizations with a valid legal status (e.g., non-profit, religious, barangay, youth and business organizations) may apply for a permit.
- 4.2 Application Form: Applicants must complete an official permit application form, which can be obtained from the Municipal Treasurer's Office, the form must include the following:
- 4.3 Name and contact information of the event organizer.
- 4.4 Date, time, and location of the event.
- 4.5 A description of the event's purpose and activities.
- 4.6 Security plan (if required).
- 4.7 Any other documentation required by the Municipality of Barugo, Leyte.
- 4.8 Deadline: Applications must be submitted at least 5 working days prior to the event to allow for the proper review and approval.

Section 5: Permit Fees

- 5.1 A non-refundable permit fee of Two Hundred Pesos **P200.00** shall be required upon submission of the application for the issuance of a disco or benefit dance permit.
- 5.2 Additional fees may apply for required services such as security, sanitation, and inspection fees.

Section 6: Event Requirements

- 6.1 Noise Level: The event shall comply with the Municipality of Barugo, Leyte noise ordinance, and no amplified music shall exceed the permissible decibel level as defined by the local regulations.
- 6.2 Security: The event organizer shall provide adequate security to ensure the safety of participants and the public. The required number of security personnel shall be determined based on the size and nature of the event.
- 6.3 Health and Safety: All health and safety regulations, including sanitation, crowd control, fire safety, and emergency medical procedures, must be followed.
- 6.4 Alcohol and Drugs: If alcohol is served, the organizer must ensure compliance with all applicable alcohol licensing laws and regulations. The consumption of illegal drugs or other controlled substances is prohibited.
- 6.5 Permitted Hours: Events shall start at 6:00 Pm and shall not extend beyond 12 midnight. Extension beyond 12 midnight shall be granted on special approval.

Section 7: Revocation of Permit

The Local Chief Executive reserves the right to revoke or suspend any permit if any of the following conditions are violated to wit:

- 7.1 Failure to comply with the terms and conditions of this ordinance.
- 7.2 Violation of any local ordinance, state, or local laws.
- 7.3 Public safety or health concerns arises before or during the event.
- 7.4 The event exceeds the allowed noise level and approved hours.

Section 8: Penalties,

Any person, juridical person or organizations that holds a disco or benefit dance without a permit has committed any violation to the provisions of this ordinance, upon conviction shall be subject to following administrative penalty of fines to wit:

8.1 First Offense: A fine of One Thousand Pesos (Php 1,000.00)

Second Offense: A fine of One Thousand Five Hundred Pesos (Php1,500.00)

Third Offense: A fine of Two Thousand Five Hundred Pesos (**Php2, 500.00**)

8.2 Failure to pay the corresponding fine and repeated violations shall ban on the grant of future permits and or institutions of any other legal actions as may deemed necessary by the Local Chief Executive.

Section 9: Enforcement

The Local Government Unit of Barugo, Leyte thru the Local Chief Executive, the Chief of Police, Municipal Fire Chief, Barangay Officials and their respective Barangay Tanods or any other relevant department are hereby authorized to enforce the provisions of this ordinance.

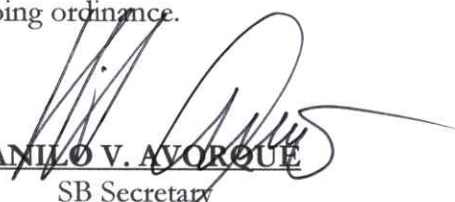
Section 10: Separability Clause - If any part or provision of this ordinance shall be held invalid, the other parts or provisions thereof not affected thereby shall remain to be in full force and effect.

Section 11: Repealing Clause - All ordinances or any provision thereof, rules and regulations inconsistent with the provision of this ordinance are hereby repealed and/or modified accordingly.

Section 12: Effectivity Clause – This ordinance shall take effects upon its approval, subject to the required posting in compliance with the provisions of RA. 7160, otherwise known as the Local Government Code of 1991.
