This office opines that the subject Ordinance is, in general, within the legislative authority of the Sangguniang Bayan to repeal/amend its prior acts either expressly or by the passage of an essentially inconsistent resolution<sup>1</sup>. Hence, we recommend for the declaration of its validity.

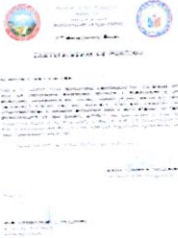

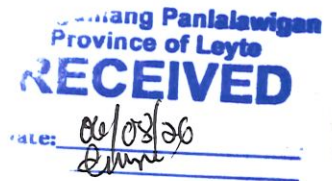

**AN ORDINANCE AMENDING SECTION 3, PARAGRAPH II OF MUNICIPAL ORDINANCE NO. 134-2021, SERIES OF 2021, ENTITLED: "AN ORDINANCE FIXING THE USE, RENTALS, FEES AND CHARGES OF CONCESSIONERS D (SEASIDE BUILDING) AND E (SICC STALLS) OF THE MUNICIPALITY OF SAN ISIDRO, LEYTE"**

Authored by: **Hon. ROLANDO C. PIAMONTE, SR**-Vice Chairman, Committee on Trade and Industry.

**WHEREAS**, the Municipality of San Isidro, Leyte, seeks to optimize the use of its Municipal owned facilities to generate local revenue and support small-scale entrepreneurs;

**WHEREAS**, there is a need to update the definition of "Concessioners E" to reflect the actual number of stalls available for lease at the SICC building;

**NOW THEREFORE, BE IT ORDAINED** by the Sangguniang Bayan of San Isidro, Leyte, in session assembled, that:

**SECTION 1. AMENDMENT.** Section 3, Paragraph II of Municipality Ordinance No. 134-2021, Series of 2021, is hereby amended to read as follows:

**"Section 3. Definition of Terms-** When used in the Ordinance, the term:

ii. Concessioners E- shall refer to the **eleven (11)** stalls owned by the Municipality of San Isidro, Leyte, located in Barangay Bawod, San Isidro, Leyte."

**SECTION 2, REPEALING CLAUSE.** All other ordinances, resolutions, or administrative orders inconsistent with the provision of this Ordinance are hereby repealed or modified accordingly.

**SECTION 3. SEPARABILITY CLAUSE.** If any part or provision of this Ordinance is declared unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

**SECTION 4. EFFECTIVITY.** This Ordinance shall take effect fifteen (15) days after its posting in at least three (3) conspicuous places within the Municipality as required by the local Government Code of 1991.
