Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 02 FY 2026** of the **Municipality of Pastrana, Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 41 Series of 2026** with a total appropriation in the amount of **P7,667,568.63** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

1. That the reversion of appropriations is duly authorized by the concerned officials and is backed up by cash collections and are made available to support the expenditures under Supplemental Budget No. 02;
2. That the allocation and utilization of the 5% Local Disaster Risk Reduction and Management Fund (LDRRMIF) shall conform with the provisions of NDRRMC-DBM and DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
3. That the procurement of Civil Works and other related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations and to the new procurement guidelines;
4. That the procurement of Motor Vehicle under Capital Outlay shall be made pursuant to the guidelines on the requisition and use of Government Vehicles under Budget Circular No. 2019-3 dated May 16, 2019; and
5. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and all other accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.

Declaration of Quorum and Call to Order

The MDC Secretary Engr. Juvilla D. Sy requested everyone to rise for the Opening Prayer, which was played through an Audio-Visual Presentation.

Thereafter, the MDC Secretary conducted the roll call of members. Out of the forty-one (41) regular MDC members, eighteen (18) Punong Barangays-MDC members were present. In addition, nine (9) representatives from Civil Society Organization (CSO) attended the meeting, along with SB member-Committee Chair on Finance, Hon. Letrodo, bringing the total attendance to twenty-eight (28) members, thereby constituting a quorum. The MDC Secretary then reported the attendance to the Presiding Officer, Hon. Maritess B. Cayaco-Marcos, MDC Chairperson.

In her opening message, the MDC Chairperson expressed her gratitude to all attendees for their presence and emphasized the importance of the meeting, particularly in relation to the municipality's Disaster Risk Reduction and Management (DRRM) programs and funds. She also informed the body that the former Municipal Disaster Risk Reduction and Management Officer (MDRRMO), Mr. Michael Castillo, had resigned from his position. She formally welcomed the newly designated MDRRMO, Engr. Glaiza A. Brazil, expressing her confidence that the new officer would efficiently perform the duties and responsibilities of the office and successfully take on the challenges of disaster risk reduction and management.

Furthermore, the Chairperson explained that the primary purpose of the meeting was to deliberate on the utilization of the MDRRM Funds, particularly the reversion of previously approved Programs, Projects, and Activities (PPAs) in favor of new PPAs that are considered more urgent and necessary. With no further matters on the declaration of attendance, the MDC Chairperson declared the existence of a quorum and formally called the meeting to order at exactly 2:00 o'clock in the afternoon.

Presentation of Agenda of the MDC Meeting

The MDC Chairperson, Hon. Maritess B. Cayaco-Marcos, requested the MDC Secretary to present the agenda for the meeting. Prior to the presentation of the current agenda, Engr. Juvilla D. Sy provided a brief recap of the resolutions approved during the 1st Quarter MDC Meeting, namely:

MDC Resolution No. 2026-01 – A Resolution Approving the Renaming of Titles of Certain Development Projects Previously Approved by the Municipal Development Council of Pastrana, Leyte; and

MDC Resolution No. 2026-02 – A Resolution Approving the Different Programs, Projects, and Activities (PPAs) Under Supplemental Investment Program (SIP) No. 01, Calendar Year 2026, to be funded from the savings of the General Fund for Fiscal Year 2025, reversion of funds from Capital Outlay, PMNP-PBG Tranche 2, LGSF-GEF, and renamed project titles under the 20% Development Fund and Capital Outlay, amounting to Eighty-Eight Million One Hundred Twenty-Nine Thousand Five Hundred Fifty-Five Pesos and Twenty-Eight Centavos (P88,129,555.28), and endorsing the same to the Sangguniang Bayan for adoption.

She further informed the body that the said resolution was subsequently adopted through **SB Resolution No. 126-2026**, dated April 6, 2026, entitled, "*A Resolution Adopting and Approving the Supplemental Investment Program (SIP) No. 01 for Calendar Year 2026 of the Municipality of Pastrana, Leyte.*"

- After the recap, the MDC Secretary presented the agenda for the meeting, as follows:
- 1. Identification and Discussion of Programs, Projects and Activities of the Supplemental Investment Program (SIP) No. 02, C.Y. 2026;
 - 2. Other Matters

Presentation of the Supplemental Investment Program (SIP) No. 02 for C.Y. 2026:

At this juncture, Ms. Anacleta G. Gabriente, Municipal Budget Officer, presented the available fund resources under the 5% Local Disaster Risk Reduction and Management Fund (LDRRMF). She explained that, similar to the municipality, any unutilized DRRM funds at the barangay level are transferred to the Trust Fund and may later be programmed through a Supplemental Investment Program, provided that the process complies with existing rules and regulations.

She disclosed that the total available fund resources amounted to **Twenty-Two Million Seven Hundred Fifty-Six Thousand Six Hundred Eighty-Five Pesos and Thirty Centavos (P22,756,685.30)**, derived from the following sources:

FUND RESOURCES:

1. LDRRM Capital Outlay from CY 2020- 2026	- 7,667,568.83

During the discussion, the MDC Chairperson encouraged all Punong Barangays to prioritize the allocation of funds for capability-building and enhancement trainings for Barangay Officials, particularly in the areas of budgeting and development planning. She emphasized that proper planning and financial management are essential for effective local governance.

Recognizing the limited resources available at the barangay level, the Chairperson assured the Barangays that the Municipal Government would continue to provide technical assistance and support through the Municipal Budget Office (MBO) and the Municipal Planning and Development Office (MPDO). Finally, she advised the Punong Barangays to begin identifying and prioritizing their respective Programs, Projects, and Activities (PPAs) for Calendar Year 2027 at the earliest opportunity to facilitate a more organized and responsive budgeting and planning process.

After that, Ms. Gabriente further explained that the Continuing Appropriation Capital Outlay DRRM Funds under the General Fund from CY 2020 to CY 2025 amounting to **Seven Million Six Hundred Sixty-Seven Thousand Five Hundred Sixty-Eight Pesos and Sixty-Three Centavos (₱7,667,568.63)** were identified under the following Programs, Projects, and Activities (PPAs):

Afterwards, the MDC Secretary proceeded with the slide presentation, detailing the proposed Programs, Projects, and Activities (PPAs) identified by the Municipal Disaster Risk Reduction and Management Council (MDRRMC), together with their corresponding appropriations from the Local Disaster Risk Reduction Management (LDRRM) Fund of previous years for transfer to Trust Fund, and proposed for inclusion in Supplemental Investment Program (SIP) No. 02 for Calendar Year 2026 in the total amount of **Fifteen Million Eighteen Nine Thousand One Hundred Sixteen Pesos and Sixty-Seven Centavos (₱15,089,116.67)**. The details of the PPAs are as follows:

Based on the PPAs presented, the total funding requirement for the proposed Supplemental Investment Program (SIP) No. 01, Calendar Year 2026, amounts to **Twenty-Two Million Seven Hundred Fifty-Six Thousand Six Hundred Eighty-Five Pesos and Thirty Centavos (P22,756,685.30)**, to be sourced from the **LDRRM Fund–Capital Outlay** and the **LDRRM Trust Fund**.

After thorough discussion and exchange of views on the different Programs, Projects and Activities (PPAs) presented, the MDC Chairperson asked the body if they are amenable to each item presented. The body replied that they abide by all the PPA's presented. Then, the MDC Secretary asked if there were comments and suggestions. Since there were none, the MDC Chairperson through the MDC Secretary requested a motion for the approval of the identified Programs, Projects and Activities (PPAs) under the Supplemental Investment Program (SIP) No. 02, C.Y. 2026.

Approval of the Supplemental Investment Program (SIP) No. 02 for C.Y. 2026:

Mr. Virgelio Estabillo, CSO President Lan-Mars Irrigators Association Inc., and Ms. Jennilyn Depaudhon, CSO President of Lourdes Unified Farmers Association moved to approve the different Programs, Projects and Activities (PPA's) under Supplemental Investment Program (SIP) No. 02 C.Y. 2026 the total amount of **Twenty-Two Million Seven Hundred Fifty-Six Thousand Six Hundred Eighty-Five Pesos and Thirty Centavos (P22,756,685.30)** and to pass a resolution approving and endorsing the same to the Sanguniang Bayan for adoption. The motion was jointly and unanimously seconded by the body. The MDC passed:

Other Matters:

Engr. Juvilla D. Sy, MDC Secretary, informed the Barangay representatives regarding the updating of their respective Barangay Development Plans (BDPs), noting that the current plans are only valid until 2026. She emphasized that proper planning should always precede the budgeting process to ensure that development programs and projects are aligned with the needs and priorities of the community.

The MDC Chairperson assured the Barangays that funds would be allocated to support the conduct of the BDP Updating Training, with four (4) participants from each Barangay expected to attend.

Thereafter, Ms. Jennilyn Depaudhon, CSO President of the Lourdes Unified Farmers Association, inquired about the release of the honorarium for CSO representatives, considering that a budget had already been appropriated for the purpose. In response, the MDC Secretary consulted the other CSO representatives and suggested that the honorarium be claimed at the end of the year, as they would still be attending the succeeding MDC meetings for the remaining quarters. The majority of the CSO representatives agreed with the proposal to receive their honorarium at the end of the year.

With no more matters to be discussed and resolved, Hon. Geraldine C. Austria, Punong Barangay of Cabaohan moved to adjourn the meeting, and was seconded by Hon. Joey L. Dominico, Punong Barangay of District III. The meeting adjourned at 3:40 in the afternoon.
