¹;Section 76. Organizational Structure and Staffing Pattern. - Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

² (vii) Subject to the provisions of this Code and pertinent laws, determine the powers and duties of officials and employees of the municipality;

(viii) Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the city government;

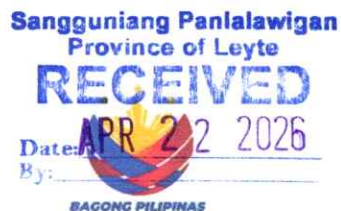

ORDINANCE NO. 2026-02

AN ORDINANCE CREATING AND FUNDING ONE (1) PLANTILLA POSITION OF PHARMACIST WITH SALARY GRADE 15 IN THE MUNICIPAL HEALTH OFFICE OF THE MUNICIPALITY OF DAGAMI, LEYTE

WHEREAS, the Municipal Government of Dagami, Leyte is mandated to provide basic health services to its constituents pursuant to the Local Government Code of 1991 (Republic Act No. 7160);

WHEREAS, the effective delivery of primary health care services requires the presence of a licensed Pharmacist to ensure the proper management, dispensing, storage, and rational use of medicines and pharmaceutical supplies in the Municipal Health Office;

WHEREAS, the absence of a Plantilla position for a pharmacist limits the Municipality's capacity to fully comply with national health standards and programs of the Department of Health;

WHEREAS, the creation of one (1) Pharmacist position with Salary Grade 15 is necessary and essential to strengthen public health services and improve access to safe and effective medicines for the people of Dagami, Leyte;

WHEREAS, funds are available and can be appropriated in accordance with existing budgeting, accounting, and auditing rules and regulations;

NOW, THEREFORE, on motion of **HON. SUSAN O. MENDOZA**, Member, Committee on Labor and Employment, duly seconded by the majority of the Sangguniang Bayan Members present, **BE IT ORDAINED** by the Sangguniang Bayan of the Municipality of Dagami, Province of Leyte, in session assembled, **THAT:**

SECTION 1. Creation of Position.

There is hereby created one (1) regular **Plantilla position of Pharmacist** under the **Municipal Health Office (MHO)** of the Municipality of Dagami, Leyte.

SECTION 2. Salary Grade.

The position of Pharmacist shall be classified under **Salary Grade 15**, in accordance with the prevailing **Salary Standardization Law** and existing rules and regulations of the Department of Budget and Management (DBM).

SECTION 3. Funding Source.

The amount necessary for the payment of salaries, allowances, and other lawful benefits of the herein created position shall be **charged against the General Fund of the Municipality of Dagami, Leyte**, subject to the usual government accounting and auditing rules. Thereafter, the same shall be included in the annual budget of the Municipality.

SECTION 4. Appointment.

The appointment to the position shall be made by the Municipal Mayor in accordance with Civil Service Commission laws, rules, and regulations, and subject to the qualification standards prescribed for the position of Pharmacist.

SECTION 5. Implementing Authority.

The Municipal Mayor, Municipal Health Officer, Municipal Budget Officer, and Municipal Accountant are hereby directed to take the necessary steps for the effective implementation of this Ordinance.

SECTION 6. Separability Clause.

If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain in full force and effect.

SECTION 7. Effectivity.

This Ordinance shall take effect **upon approval** and after compliance with the required posting and publication pursuant to law.

ENACTED this 4th day of February, **2026**, at the Municipality of Dagami, Province of Leyte.
