**A RESOLUTION ACKNOWLEDGING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2026-03 AND TAKING COGNIZANCE OF THE SUPERVENING DEVELOPMENTS RELATIVE TO THE BOUNDARY DISPUTE BETWEEN THE MUNICIPALITIES OF BURAUEN AND ALBUERA**

**WHEREAS**, the Municipal Development Council of Burauen adopted Resolution No. 2026-03 entitled, "A Resolution Requesting the Local Government Unit of Burauen, Leyte through the Sangguniang Bayan to Intervene to Maintain the Status Quo of the Boundary Dispute of the Municipalities of Burauen and Albura";

**WHEREAS**, the Sangguniang Bayan received and deliberated upon said Municipal Development Council Resolution through the appropriate committees;

**WHEREAS**, subsequent thereto, the Municipality of Albura submitted a Written Explanation in compliance with Provincial Resolution No. 2026-842 relative to the installation of the "Welcome Panan-awan Peak – Municipality of Albura" signage, which was referred to the Committee on Boundary Disputes and on Ways and Means of the Sangguniang Panlalawigan of Leyte for evaluation and recommendation;

**WHEREAS**, the Committee on Boundary Disputes and on Ways and Means of the Sangguniang Panlalawigan of Leyte thereafter issued Committee Report No. 17 dated June 8, 2026, taking cognizance of the Written Explanation and recommending further proceedings, including the maintenance of the status quo ante pending final determination of the boundary dispute;

**WHEREAS**, the Sangguniang Bayan deems it proper to acknowledge Municipal Development Council Resolution No. 2026-03 and take cognizance of the supervening developments relative thereto for the information and guidance of all concerned;

**NOW, THEREFORE**, upon motion duly made and seconded, be it:

**RESOLVED**, as it is hereby **RESOLVED**, by the Sangguniang Bayan of Burauen, Leyte, in session assembled, to acknowledge Municipal Development Council Resolution No. 2026-03 and take cognizance of the supervening developments relative to the boundary dispute between the Municipalities of Burauen and Albura, particularly the submission of the Written Explanation by the Municipality of Albura and the issuance of Committee Report No. 17 by the Committee on Boundary Disputes and on Ways and Means of the Sangguniang Panlalawigan of Leyte;

**RESOLVED FURTHER**, to furnish copies of Committee Report No. 17 of the Committee on Boundary Disputes and on Ways and Means of the Sangguniang Panlalawigan of Leyte, together with this Resolution, to the Municipal Development Council, Barangay Villa Corazon through Punong Barangay Rowena Portillo, and other concerned offices for their information and appropriate action.

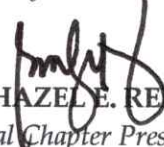

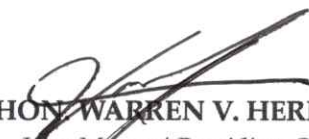
