

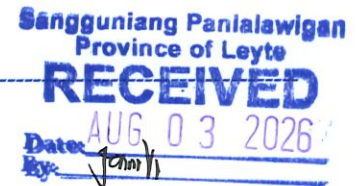

- Ordinance No. 26-123 entitled: “ **Ordinance awarding of franchise to Jahn Jahn Alicando the operation of a motorized tricycle-for-hire along the Poblacion Route within the territorial jurisdiction of the Municipality of Burauen, Leyte.**”

**REVIEW/RECOMMENDATION/LEGAL OPINION:**

This office opines that the subject Ordinance is, in general, within the legislative authority of the Sangguniang Bayan under Section 447(a)(3)(vi)<sup>1</sup> of the Local Government Code of 1991 (R.A 7160). Hence, we recommend for the declaration of its validity.

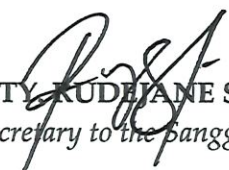

AN ORDINANCE AWARDING A FRANCHISE TO JAHN JAHN P. ALICANDO FOR THE OPERATION OF A MOTORIZED TRICYCLE-FOR-HIRE ALONG THE TAMBUCO-MARKET (BASTTODA) ROUTE, MUNICIPALITY OF BURAUEN, LEYTE

WHEREAS, Section 447(a)(3)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to regulate the operation of tricycles-for-hire and grant franchises for their operation within the municipality;

WHEREAS, Jahn Jahn P. Alicando has applied for a franchise to operate a motorized tricycle-for-hire along the Tambuco - Market (BASTTODA) route within the Municipality of Burauen, Leyte;

WHEREAS, the Committee on Transportation, Public Utilities, and General Services favorably recommended the granting of the said franchise;

NOW, THEREFORE, upon the motion duly made and seconded, be it enacted by the Sangguniang Bayan of Burauen, Leyte, in session assembled:

**Section 1. GRANT OF FRANCHISE.** A franchise is hereby granted to JAHN JAHN P. ALICANDO to operate one (1) unit of motorized tricycle-for-hire along the Tambuco - Market (BASTTODA) route within the territorial jurisdiction of the Municipality of Burauen, Leyte.

**Section 2. VEHICLE SPECIFICATIONS.** The authorized unit shall have the following specifications:

**Section 3. PERIOD OF FRANCHISE.** The franchise granted herein shall be valid for a period of three (3) years from the approval of this Ordinance, unless sooner revoked or suspended for cause, and may thereafter be renewed upon proper application and compliance with applicable requirements.

**Section 4. COMPLIANCE.** The grantee shall comply with all applicable rules and regulations of the Municipality of Burauen and the Land Transportation Office (LTO), and shall secure the necessary permits and clearances for the continued operation of the franchise.

**Section 5. REPEALING CLAUSE.** All ordinances, resolutions, rules, and regulations, or parts thereof, that are inconsistent with the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

**Section 6. SEPARABILITY CLAUSE.** If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue to be in full force and effect.

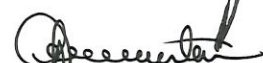
**Section 7. EFFECTIVITY.** This Ordinance shall take effect immediately upon approval.
