ORDINANCE NO. 07, SERIES 2026

**AN ORDINANCE FOR THE GRANT OF FRANCHISE TO TRICYCLE FOR
HIRE TO TRANSPORT PASSENGERS AND/OR CARGOES WITHIN THE
MUNICIPALITY AND FOR OTHER PURPOSES**

**BE IT ENACTED BY THE 20TH SANGGUNIANG BAYAN OF ABUYOG, LEYTE IN
SESSION DULY ASSEMBLED that:**

SECTION 1: TITLE – This Ordinance shall be known as the “**AN ORDINANCE FOR THE
GRANT OF FRANCHISE TO TRICYCLE FOR HIRE TO TRANSPORT PASSENGERS
AND/OR CARGOES WITHIN THE MUNICIPALITY AND FOR OTHER PURPOSES**”.

SECTION 2. Objective – The objective and purpose of this Ordinance is to provide
convenience and service to riding public and on the other hand provide income to the
operators and drivers to these tricycles and additional revenue to the Municipality as well.

SECTION 3. Definition of Terms:

- Municipality – refers to the Municipality of Abuyog, Province of Leyte
- Tricycle for Hire – A vehicle similar to a bicycle, but having three (3) wheels, two at the back and one at the front and/or a type of motorized vehicle consisting of a motorcycle and a passenger cab attached to it both duly registered with the LTO to transport passenger and/or cargoes.
- Sangguniang Bayan or Sangguniang – refers to the Sangguniang Bayan of Abuyog, Leyte.
- Secretary – refers to the Secretary of the Sangguniang Bayan of Abuyog, Leyte.

SECTION 4. Creation of New Route – a.) There shall be created a new route from the town proper of this Municipality at the New Bus Terminal at Brgy. Nalibunan (Tab-ok) Abuyog, Leyte to Brgy. Bagacay, Abuyog, Leyte plying through the coastal road and vice versa.

b.) Likewise, a new route from the town proper of this Municipality at the New Bus Terminal at Brgy. Nalibunan (Tab-ok), Abuyog, Leyte to Brgy. Pinamanagan, Abuyog, Leyte plying through the upper Higasaan Road and vice versa.

c.) Vehicles eligible for this route are tricycles for hire (bao-bao) who shall apply and secure a franchise to operate from the Sangguniang Bayan of this Municipality upon payment of a fixed fee in the amount of Four Thousand (4,000.00) Pesos to the treasurer of this municipality upon Order of Payment duly issued by the Secretary.

SECTION 5. Application and Renewal of Franchise – a.) Application to secure a franchise or renewal of franchise to operate a tricycle for hire to transport passengers or cargo within the Municipality shall be filed with the Sangguniang Bayan through its Secretary.

b.) The secretary upon receipt of the application shall place an application number on it, in accordance with the priority of the application filed beginning the first two (2) numbers representing the last two number when the year it was filed and the succeeding number representing the order of priority from 001 and so forth.

c.) Such application number shall become the permanent body number of the tricycle and which shall be painted in the tricycle itself and shall likewise be used as his permanent franchise number for its renewal.

d.) Such application or renewal shall then be set in the calendar of business during the next regular session by the secretary for the consideration or appropriate action by the Sangguniang.

e.) Such application or renewal, shall contain the following information:

a. The full name of the applicant for the application or renewal who shall be the registered owner of the tricycle for hire or the vendee or transferee thereof;

b. The motor number and chassis number of the tricycle for hire sought to be applied or renewed;

c. Name of spouse, children who are living together with the applicant;

d. Photocopy of the Certificate of Registration and latest Official Receipt from LTO of the tricycle for hire subject for application or renewal.

SECTION 6. Issuance of Sticker – a. Upon approval of the application or renewal and payment of fixed application or renewal fee, the secretary shall issue a STICKER representing the year when was the application or renewal granted.

b. The franchise owner shall be visibly paste said sticker in front of his motorcycle as would apprise traffic enforcer or police personnel of the grant of its application or renewal or the traffic enforcer or police personnel shall require the driver to show the copy of the approved Sangguniang Resolution granting such application or renewal.

c. The Secretary as such, is hereby empowered to purchase and secure such sticker.

SECTION 7. Payment of Application or Renewal Fees – a. All Tricycle for hire to transport passengers and/or cargo operating within the municipality such as plying the route to Barangays Balinsasayao, Bagacay, Pinamanagan, shall apply or renew a franchise to operate a tricycle for hire to transport passengers and/or cargo upon payment of a fixed fee in the amount of Four Thousand (4,000.00) Pesos annually to the treasurer of this Municipality upon Order of Payment duly issued by the Secretary after approval by the Sangguniang of the application or renewal.

b. Tricycle (motorpot) plying the route within the town proper of Abuyog, Leyte shall likewise apply or renew franchise to operate tricycle (motorpot) to transport passengers and/or cargo within the town proper of Abuyog, Leyte upon payment of a fixed fee in the amount of Two Thousand Eight Hundred (2,800.00) Pesos annually to the treasurer of this Municipality upon Order of Payment duly issued by the Secretary after approval of the application or renewal.

SECTION 8. Creation of Special Route – a. There shall be created a special route from crossing Tabigue at Brgy. Balocawe, Abuyog, Leyte to Upper Higasaan of this Municipality and vice versa.

b. Vehicles eligible for this route are tricycles without yet a franchise who are already catering and serving this route and shall apply and secure a franchise to operate from the Sangguniang Bayan of this Municipality upon payment of a fixed amount of four Thousand (4,000.00) Pesos to the treasurer of this Municipality upon an Order of Payment duly issued by the Secretary after approval by the Sangguniang of the application or renewal.

SECTION 9. Establishment of Parking Area – a. Operator or owner of tricycle for hire who successfully secured a franchise to operate in accordance with Section 8 hereof shall establish and maintain a parking area of their own in its operation and shall be prohibited from using the National Highway or its shoulders as parking area.

b. Tricycle using the Abuyog Bus Terminal may likewise establish their own private terminal outside the Abuyog Bus Terminal provided that such private terminal shall secure business permit for its operation from the Office of the Municipal Mayor.

SECTION 10. Limitation of the Special Route – Tricycles operating this special route are prohibited to pick up passengers on their way to and going back to their parking area.

SECTION 11. Prohibition of Out of Line Travel – a. Every motorcycle for hire including motorpot herein granted a franchise are prohibited and shall not be allowed from transporting passengers and/or cargoes beyond their specified route, except when the registered owner or vendee of the subject motorcycle for hire was duly issued by the Civil Security Office of a special permit to transport passengers provided such passengers shall be limited to his family members listed on his application or renewal for the purpose of family gathering but not exceed the allowable passenger to his vehicle.

b. Any aggrieved party may file a protest to the Sangguniang against any violator (registered owner or vendee or driver) of this prohibition which shall cause suspension or revocation of his franchise by the Sangguniang.

SECTION 12. This Ordinance is however without prejudice if there are already approved routes by the LTFRB and are already operational in these routes to Barangays Pinamanagan, Balinsasayao, and Bagacay of this Municipality.

SECTION 13. Separability Clause – That if any of the provision of this ordinance shall be declared invalid, it will not affect the valid provision.

SECTION 14. Amendment or Repeal – Section 1 (page 17) of the Traffic Code of the Municipality of Abuyog, Leyte (Ordinance No. 02, s. 2013) is hereby amended or repealed and the creation of the Municipal Franchising and Regulatory Board and one terminal policy are likewise repealed accordingly to conform to the foregoing new ordinance.

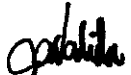
SECTION 15. Penalty – Any person violating any of the provision of this ordinance shall pay a fine of Two Thousand (2,000.00) Pesos or an imprisonment of not more than five days or both.



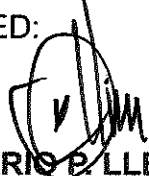
SECTION 16. Effectivity – This Ordinance shall take effect immediately upon its approval.
