AN ORDINANCE AMENDING APPROPRIATION ORDINANCE NO. 2025-06, ENTITLED "AN ORDINANCE AUTHORIZING ANNUAL BUDGET OF ALBUERA, LEYTE IN THE TOTAL AMOUNT OF THREE HUNDRED FIFTY-NINE MILLION TWO HUNDRED FIFTY THOUSAND EIGHT HUNDRED NINETY-SEVEN PESOS (PHP359,250,897.00) COVERING THE VARIOUS EXPENDITURES FOR THE OPERATION OF THE MUNICIPAL GOVERNMENT FOR FISCAL YEAR 2026, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE" BY MAKING A TYPOGRAPHICAL CORRECTION THEREIN

WHEREAS, the Sangguniang Bayan of Albura, Leyte enacted APPROPRIATION ORDINANCE NO. 2025-06 authorizing the General Fund Annual Budget of the Local Government Unit for CY 2026;

WHEREAS, upon review of the said ordinance, a typographical error was discovered in the "Special Purpose Appropriations – Tourism and Socio-Cultural Activities" under Municipal Mayor's Office in the General Fund Annual Budget CY 2026 of Albura, Leyte, where the "Activity" was inadvertently indicated as "Miss Albura Tourism 2025" appears instead of "Miss Albura Tourism 2026";

WHEREAS, the correction is purely clerical/typographical in nature and will not alter the total amount of the approved budget, the intent of the appropriation, or any substantive provision of the original ordinance;

WHEREAS, it is necessary to enact an amendatory ordinance to rectify the error for accuracy, clarity, and proper implementation of the budget; **BE IT ORDAINED** by the Sangguniang Bayan in session assembled that:

SECTION 1. The typographical error in APPROPRIATION ORDINANCE NO. 2025-06 is hereby corrected as follows:

- In "Special Purpose Appropriations" – Tourism and Socio-Cultural Activities" under Municipal Mayor's Office, the Activity "Miss Albura Tourism 2025" is hereby amended to read "Miss Albura Tourism 2026".

SECTION 2. All other provisions of APPROPRIATION ORDINANCE NO. 2025-06 not inconsistent with this amendatory ordinance shall remain in full force and effect.

SECTION 3. Separability Clause. If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

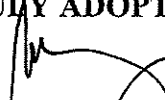

SECTION 5. Effectivity Clause. This Ordinance shall take effect immediately upon its approval and publication as required by law.

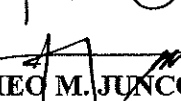
