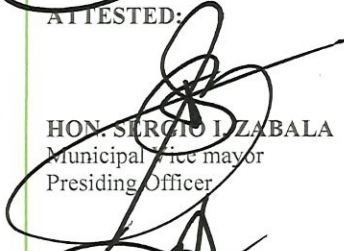

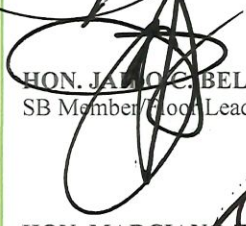
WHEREAS, the Municipality of Mayorga has enacted Municipal Ordinance No. 2012-28 (Motorcycle Helmet Ordinance), Municipal Ordinance No. 2016-75 (Penalizing vehicles using modified mufflers that create excessive and irritating noise), and Municipal Ordinance No. 2017-81 (Prohibiting minors eighteen [18] years old below from operating any kind of vehicle), in order to promote road safety, protect minors, reduce noise pollution, and maintain public order within its jurisdiction;

WHEREAS, these ordinances were passed to safeguard the welfare of motorists, pedestrians, and the general public, and to instill discipline and responsibility among road users within the Municipality;

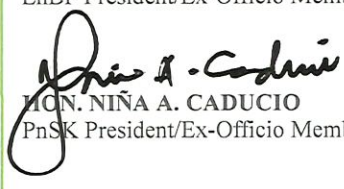

WHEREAS, the effective and consistent enforcement of the aforementioned ordinances is essential to achieving their intended objectives;

WHEREAS, the establishment of a uniform Traffic Citation Ticket system will institutionalize proper documentation, promote transparency and accountability among enforcing officers, and ensure that due process is observed in the handling of traffic violations;

WHEREAS, the proposed measure does not amend nor alter the existing penalties provided under the concerned ordinances but merely provides an administrative mechanism to strengthen and ensure their effective implementation;

NOW THEREFORE, on motion by the **Honorable Joseph A. Amante**, duly seconded by the **Honorable Henry B. Lagarto**; be it

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF MAYORGA, IN SESSION ASSEMBLED, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:

SECTION 1. TITLE.

This Ordinance shall be known as the **“Unified Traffic Citation Ticket Ordinance of the Municipality of Mayorga.”**

SECTION 2. DECLARATION OF POLICY.

It is hereby declared the policy of the Municipality of Mayorga to:

- Promote road safety and protect life and property;
- Prevent traumatic injuries and fatalities resulting from vehicular accidents;
- Protect minors from exposure to road hazards;
- Reduce noise pollution caused by unauthorized vehicle modifications;
- Ensure strict, uniform, and transparent enforcement of municipal traffic ordinances; and
- Institutionalize a standardized citation system to uphold accountability and due process.

SECTION 3. COVERAGE.

This Ordinance shall apply to violations of the following:

- Municipal Ordinance No. 2012-28 – Motorcycle Helmet Ordinance;
- Municipal Ordinance No. 2016-75 – Modified Muffler Ordinance;
- Municipal Ordinance No. 2017-81 – Prohibition on Minors Operating Vehicles;

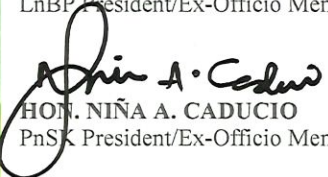

4. Other related municipal traffic ordinances which the Sangguniang Bayan may later include.

SECTION 4. CREATION OF UNIFIED TRAFFIC CITATION TICKET (TCT).

There is hereby created a standardized, serialized, and accountable Traffic Citation Ticket (TCT) to be issued for all violations covered under this Ordinance.

The TCT shall serve as:

- Official notice of violation;
- Basis for payment of fines;
- Authority for vehicle impoundment when applicable;
- Official enforcement documentation.

SECTION 5. AUTHORIZED APPREHENDING OFFICERS.

The following are authorized to issue Traffic Citation Tickets:

- Local Police Officers;
- Duly designated Municipal Traffic Enforcers;
- Deputized Incumbent Elected Barangay Officials;
- Deputized Barangay Tanods;

SECTION 6. CONTENTS OF THE TRAFFIC CITATION TICKET.

The TCT shall contain:

- Control/serial number;
- Name and address of violator;
- Age (for purposes of minor determination);
- Vehicle description and plate number;
- Violation;
- Date, time, and place of violation;
- Name and signature of apprehending officer;
- Signature of violator (or notation of refusal);
- Fine and corresponding penalty;
- Impoundment details, if applicable;
- Instructions for payment and settlement.

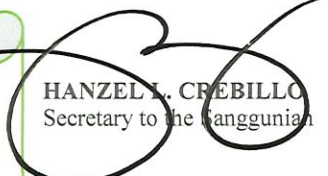
The Municipal Mayor, through the appropriate office, is authorized to approve the final format and security features of the Traffic Citation Ticket.

SECTION 7. SPECIFIC IMPLEMENTATION GUIDELINES.

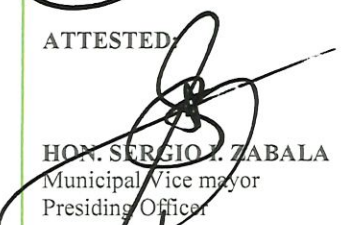
A. Motorcycle Helmet Violations

Violations shall include:

- Non-wearing of standard protective motorcycle helmet;
- Improper wearing of helmet;
- Use of tinted face shield;

- Other prohibited acts under Municipal Ordinance No. 2012-28.

Liability shall rest upon the driver/rider, including responsibility for back riders.

Penalties shall follow the graduated fines provided under the said ordinance.

B. Modified Muffler Violations

Vehicles using modified mufflers creating excessive and irritating sound shall:

1. Be issued a TCT;
2. Be immediately impounded at the Mayorga Police Station or designated impounding area.

Impoundment period:

- 1st Offense – 1 day;
- 2nd Offense – 2 days;
- 3rd Offense – 3 days.

Offenders shall restore or replace the muffler to manufacturer standard after serving the penalty. Restoration or replacement of modified mufflers shall be conducted within the designated impounding area. LTO Official Receipt or Certificate of Registration of the vehicle must be presented prior to the release of the vehicle. In the absence of such, a Deed of Sale may suffice.

C. Minor Operating Vehicle Violations

If a minor is found operating a vehicle:

1. A TCT shall be issued;
2. Liability shall attach to the parent/guardian or vehicle owner;
3. The vehicle may be impounded if penalties are not paid.

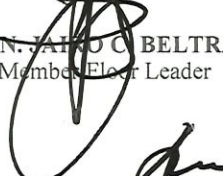
Penalties shall follow the graduated fines and sanctions under Municipal Ordinance No. 2017-81. Impounding fee shall be Fifty Pesos (Php 50.00) per day, subject to the maximum period provided therein. LTO Official Receipt or Certificate of Registration of the vehicle must be presented prior to the release of the vehicle. In the absence of such, a Deed of Sale may suffice.

SECTION 8. PAYMENT OF FINES.

- a. No on-the-spot collection shall be allowed.
- b. All fines shall be paid at the Municipal Treasurer's Office within fifteen (15) days from the date of issuance of the Traffic Citation Ticket. Failure to pay within the prescribed period shall result in the imposition of surcharges. Failure to settle obligations after thirty (30) days shall warrant the filing of appropriate charges in accordance with existing laws and ordinances.
- c. LGU Official receipt must be presented prior to vehicle release, when applicable.

SECTION 9. RECORD-KEEPING AND MONITORING.

The Municipal Treasurer and designated enforcement office shall maintain:

- a. Registry of issued TCTs;
- b. Monitoring system for repeat offenders;
- c. Monthly enforcement reports to the Sangguniang Bayan.

SECTION 10. ADMINISTRATIVE LIABILITY.

Law enforcement agents who fail to enforce or who violate provisions of the covered ordinances shall be subject to administrative sanctions in addition to penalties prescribed under existing laws.

SECTION 11. APPROPRIATIONS.

Funds necessary for printing secure citation tickets, logbooks, noise detecting device and other enforcement materials shall be charged against available municipal funds.

SECTION 12. SEPARABILITY CLAUSE.

If any provision of this Ordinance or any part thereof be declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 13. APPLICABILITY CLAUSE.

All other matters related to the impositions of this ordinance shall be governed by the pertinent provisions of existing laws and other ordinances.

SECTION 14. REPEALING CLAUSE.

All ordinances, resolutions, executive orders or regulations and other issuances inconsistent with the provisions and/or purposes of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 15. EFFECTIVITY CLAUSE.

This ordinance shall take effect upon approval by the Sangguniang Panlalawigan of Leyte.
